Online registration is mandatory to secure the Certificate of Appearance and Certificate of Participation. No registration, no certificates.

Participants are advised to observe the following:

- Participants are expected to arrive at 12:00nn on December 8, 2025, and may proceed to the Information/Front Desk for room assignments. The opening program will begin at 2:00 p.m.
- 2. Please note that December 8, 2025 (Day 1) is a Special Non-Working Holiday in observance of the Feast of the immaculate Conception of Mary, as per the Official Gazette of the Republic of the Philippines. In view of this, participants are respectfully requested to be granted Compensatory Time Off (CTO) for their active participation on that day.
