SUBJECT: **CONSULTATION WORKSHOP ON THE PMES TOOLS FOR TEACHERS IN RELATION TO REFRAMING THE CLASSROOM OBSERVATION PROTOCOLS**

The Bureau of Human Resource and Organizational Development – Human Resource Development Division (BHROD-HRDD) will be conducting **Consultation Workshop with Stakeholders for the Performance Management and Evaluation System (PMES) of Teachers** in relation to reframing the classroom observations, scheduled on **January 19-21, 2026, at the Axiaa Hotel, Quezon City**.

This workshop aims to:

1. Discuss the proposed strategic recommendations and implementation implications to reframing the classroom observations from high-stakes to low-stakes;
2. Gather feedback and insights from field-level implementers to ensure clarity, feasibility, and contextual relevance of the guidelines and tools for performance evaluation; and
3. Finalize the guidelines and tools to support effective and consistent teacher performance assessment across the school years.

Due to its significant importance and urgency as a directive by Secretary Angara, where the guidelines on the reframed classroom observation and PMES tools will serve as the official reference of teachers and raters for School Years 2025-2026 to SY 2027-2028, the **DepEd personnel listed in Annex A are requested to participate in the workshop**. These participants contributed to the development of the Multi-Year PMES Guidelines, the PMES Tools, and other programs and projects related to classroom observations and the Professional Standards for Teachers.
