**ENDORISING THE QUICK MONITORING SYSTEM (QMS) TO THE
AGENCY CENTRAL OFFICES FOR ADOPTION IN THE MONITORING
OF ALL INFRASTRUCTURE PROJECTS IN THE COUNTRY**

WHEREAS, per Executive Order No. 82, Series of 2025, which strengthens the RDCs, the RDCs serve as the highest planning and policy-making body for socio-economic development in the region, acting as the primary convergence platform for local government units (LGUs), regional line agencies, state universities and colleges (SUCs), and private sector representatives (PSRs);

WHEREAS, the RDC VIII has recognized the need for a secure and comprehensive online platform to enhance engagement, interconnectivity, and efficient databasing and information exchange among its members and stakeholders, pursuant to Section 5-h of the Implementing Rules and Regulations of RA 12145 or the "Economy, Planning, and Development Act";

WHEREAS, in response, the RDC VIII approved the creation of the RDC VIII Dashboard through Resolution No. 61-B, Series of 2022 (**Annex A**);

WHEREAS, the Council further passed RDC VIII Resolution No. 21, Series of 2025 (**Annex B**), which approved the establishment of the RDC VIII Information System Innovation (RDC VIII ISI), renamed as the RDC VIII Science and Technology-based Policies Innovative Information System (RDC VIII S&T-PISI), which expanded the scope of the RDC VIII Dashboard to develop an innovative information management system that will digitize, integrate, and streamline the processes of the RDC VIII in the (1) submission and evaluation of program and project (PAP) proposals for the annual budget review, (2) monitoring of the implementation of the PAPs once approved, and (3) performance of the Secretariat functions;

WHEREAS, the RDC VIII Chairperson, Governor Carlos Jericho L. Petilla, presented the Quick Monitoring System (QMS), an initiative of his that the Provincial Government of Leyte is implementing and which has proven to be effective;

WHEREAS, the QMS focuses on the monitoring of infrastructure project implementation, whereby implementing contractors are required to provide real-time – daily minute-by-minute timelapse – snapshots viewable online through onsite cameras from the start of an infrastructure project until its completion or termination;

WHEREAS, the QMS can be scaled up and used in all infrastructure projects of the government to ensure transparency and accountability in project implementation.

NOW, THEREFORE, upon the motion of the RDC VIII-Infrastructure Development Committee Co-Chairperson and PSR for Energy, Dr. Allan L. Laniba, duly seconded by RDC VIII-Social Development Committee Co-Chairperson and PSR for Labor, Bellsedaize C. Acaso, **BE IT RESOLVED, AS IT IS HEREBY RESOLVED**, to endorse the QMS to the Agency Central Offices for adoption in the monitoring of all infrastructure projects in the country.
