SUBJECT : **STOPPAGE OF REMITTANCE OF LOAN COLLECTION TO AMA RURAL BANK OF MANDALUYONG, INC.**

This refers to the payment of the withheld loan collections from the Department of Education (DepEd) Regional Offices I, II, III, IV-A, VIII, Cordillera Administrative Region (CAR) and National Capital Region (NCR), to AMA Rural Bank of Mandaluyong, Inc. (AMA Bank), pursuant to the approved DepEd – AMA Bank Compromise Agreement and Certified Withheld Collections as signed by the respective Regional Directors.

As provided in the Compromise Agreement, DepEd shall remit only the certified withheld collections covering the period from AMA Bank's closure on November 08, 2019, until June 2025.

In this regard, all concerned Regional Offices and School Division Offices (SDOs) are hereby directed to cease the remittance of loan amortizations from DepEd borrowers on their loan with AMA Bank. AMA Bank shall directly coordinate with the borrowers for the collection of their outstanding obligations.

Furthermore, any remaining unpaid or unremitted collections outside the certified and approved amounts shall not be processed without prior review and explicit approval of the Assistant Secretary for Finance, as the Officer-in-charge of the Office of the Undersecretary for Finance.
