**CONDUCT OF THE ON-SITE NATIONAL JUDGING FOR THE BEST  
IMPLEMENTING SCHOOL COMPETITIONS UNDER THE  
NESTLÉ WELLNESS CAMPUS PROGRAM (NWCP)  
AND OTHER RELATED ACTIVITIES**

To: Schools Division Superintendents  
All Others Concerned

1. Pursuant to the Department of Education's commitment to promoting health, wellness, and holistic development among learners, and in line with its partnership with Nestlé Philippines, Inc. (NPI) under the Nestlé Wellness Campus Program (NWCP), the conduct of national-level activities recognizing exemplary school-based wellness initiatives is hereby supported and facilitated.
2. The on-site national judging aims to determine the Best Implementing Schools among the nine (9) participating regions, based on established criteria aligned with the objectives of the NWCP.
3. The On-site National Judging for the Best Implementing School Competitions under the Nestlé Wellness Campus Program shall be conducted on January 19–20, 2026, specifically on the following schools:

The judging activities shall be facilitated by representatives from Nestlé Philippines, Inc., headed by the Nutrition Advocacy Executive and NWCP Program Lead, Ms. Charisma Sy, in partnership with Greatfil Team, Inc., headed by its President, Mr. Patricio Goc-ong, and National Operations Head, Ms. Lovely Erosa.
5. In support of Region VIII's entry to the DepEd Region VIII **Hataw Sayaw Year 3 competition**, all teachers and learners of DepEd Region VIII are hereby enjoined to actively support and engage by viewing and promoting the official entry video through the **Nestlé Wellness Homeroom-Parents' Community** platform, subject to existing DepEd policies on responsible digital engagement.
6. Further, the National Judging for the **Sarap Sustansya Cook-Off** is scheduled on February 26 to March 1, 2026.

The official Regional Representative under the Junior High School Category is Conception National High School, Schools Division of Southern Leyte.

7. All participating learners and their respective coaches for both activities shall be fully provided with transportation, meals for the entire duration of the events, and hotel accommodation by Nestlé Philippines, Inc. (NPI) through its partner, Greatfil Team, Inc.


To support the participants' engagement, we kindly seek your assistance in the following:
