**UPDATES ON THE VALENTINE'S MAKEOVER PROJECT
FOR TEACHERS AND PRINCIPALS**

To: Schools Division Superintendents
All Others Concerned

1. In reference to Regional Memorandum CLMD-2026-117 dated January 27, 2026, this Office hereby issues the following updates relative to the conduct of the Valentine's Makeover Project for Teachers and Principals with the following details:

a. Schedule and Venue

The activity shall be conducted on **February 14, 2026** (Saturday) at **Tandaya Hall, Catbalogan City**.

b. Participants and Allocation

A total of one hundred (100) participants shall attend the activity, coming from the Schools Division of Samar and the Schools Division of Catbalogan City, with the following allocation:

- Samar Division - 50 participants (20 School Heads & 30 Teachers)
- Catbalogan City Division - 50 participants (20 School Heads & 30 Teachers)

c. Funding Support

Funds amounting to One Hundred Thousand Pesos Only (₱100,000.00) has been downloaded to the Schools Division of Catbalogan City (SARO No. OSEC-8-26-00012) to support the conduct of the said activity.

d. Utilization of Funds

The downloaded funds may be utilized for the following authorized expenses:

- Food for the JDVP Partners and other volunteers;
- Prizes for games and other related activities;
- Room accommodation and food of the Central Office guests and the Regional Office advance party.
- Other expenses as may be deemed necessary by the co-hosts.

4. All the Regional Office participants shall depart from the station on 13 February 2026 to be able to last minute preparations and check the venue.

All participants shall be duly provided with meals, specifically: breakfast for fifty (50) members of the Technical Working Group (TWG), and morning snacks, lunch, and afternoon snacks for one hundred fifty (150) teachers, school heads, and TWG members, to be shouldered by the Local Government Unit (LGU) of the Province of Samar. The JDVP partners and other volunteers shall likewise be provided with morning snacks, lunch, and afternoon snacks, chargeable against the funds downloaded by the CO-EPS to the Schools Division of Catbalogan City, while expenses pertaining to the transportation and other necessary incidental costs of the participants shall be charged to their respective Local Funds, Maintenance and Other Operating Expenses (MOOE), Special Education Fund (SEF), Program Support Fund (PSF), or other available fund sources, whichever may be applicable, subject to existing budgeting, accounting, procurement, and auditing laws, rules, and regulations.

In celebration of Valentine's Day and in recognition of the invaluable service and dedication of our public-school teachers and principals, the Department of Education (DepEd), in partnership with the Technical Education and Skills Development Authority (TESDA) and other stakeholders, will implement the **Project: Valentine's Day Teachers and Principals Makeover**.

This project aims to provide a special pampering and makeover experience for our principals and teachers, which includes the provision of makeup kits and services such as hairdressing, makeup, manicure and pedicure, facial, massage, and other wellness services.

The activity is targeted to be conducted on **February 14, 2026 (Saturday)**, with **100 teachers and principals per region**, or a total of **1,700 beneficiaries nationwide**. Venues shall be determined by the respective regional offices (ROs).

In this regard, all ROs are directed to

- a. identify one schools division office (SDO) per region that will serve as the host of the activity;
- b. identify the venue for the said activity within the region;
- c. develop and manage a regional registration form, noting that the first 100 teachers and principals per region who successfully register shall be accommodated for the makeover services; and
