**MONITORING AND VALIDATION OF DELIVERED LEARNING TOOLS
AND EQUIPMENT FOR SENIOR HIGH SCHOOL TECHNICAL
VOCATIONAL LIVELIHOOD (TVL) TRACK**

To: Schools Division Superintendents
All Others Concerned

1. This Office, through the Curriculum and Learning Management Division (CLMD) and the Asset Management Section (AMS), shall conduct the monitoring and validation of delivered Learning Tools and Equipment (LTE) for the Senior High School Technical-Vocational-Livelihood (TVL) Track in recipient schools under the 2024 and 2025 procurement and delivery of SHS TVL LTE.
2. The purposes of the monitoring and validation are as follows:
 - a. Verify the correctness and completeness of delivered Learning Tools and Equipment (LTE);
 - b. Ensure that the delivered LTE meets required standards and specifications;
 - c. Confirm proper receipt and use of LTE by recipient schools; and
 - d. Identify issues and recommend appropriate corrective actions.

3. The Schools Division Office, through the Education Program Supervisor (EPS) for SHS TVL, shall coordinate with the regional monitors and participate in the monitoring and validation of the identified recipient schools according to the following schedules. In cases of scheduling conflicts, the EPS shall ensure that a Division representative participates in the monitoring activity.

5. Expenses incurred by the regional personnel in relation to this activity shall be charged against the Local Funds, while those incurred by division personnel shall be charged against their respective Division Local Funds, subject to the usual government accounting rules and regulations.
