4. Immediate dissemination of and compliance with this Memorandum are desired.



SUBJECT : FOLLOW-THROUGH ON THE DEVELOPMENT OF CHILD PARTICIPATION
GUIDELINES FOR JJWC AND RJJWCS OPERATIONS AND PROCESSES

This is to gently follow-up on our previous memorandum dated 27 October 2025 (please see attached) requesting for inputs and comments on the enhanced draft child participation guidelines for the JJWC and RJJWC operations and processes.

This is also to inform the regional committees that a validation workshop on the enhanced draft guidelines will be **conducted on February 24 to 27, 2026** (inclusive of travel time) in Metro Manila. The validation activity aims to determine the usefulness, accuracy, user-friendliness, and clarity of the enhanced draft guidelines.

Given this, we would like to invite/request each region to send a representative to participate in the validation activity in February. For continuity purposes, may we propose that each region send the same representative that participated in the consultation workshop last October. We will appreciate receiving **confirmation of the name of the representative not later than January 30, 2026**.

Further, we would like to inform the RJJWC secretariats that we will treat the participants confirmed on the set deadline as final to avoid (1) costly airfare due to the delay in the booking of air travel, and (2) cancellation fees arising from changes in the participants. The secretariats are enjoined to inform the target participants regarding this.
