4. Provision of meals chargeable against the EVRAA FUNDS 2026 shall cover the period February 26-28, 2026. Expenses incurred prior to the aforementioned dates, including meals and travel expenses from the participants' division to SDO Baybay and vice versa, shall be charged against their respective MOOE/local funds, subject to the usual government accounting and auditing rules and procedures.
