**REGIONAL TRAINING ON NATIONAL ACHIEVEMENT TEST (NAT) ANALYTICS
FOR DIVISION TESTING COORDINATORS (DTCs)**

To: Schools Division Superintendents
Division Testing Coordinators
All Others Concerned

1. To ensure the results of the 2024 National Achievement Test (NAT) are thoroughly analyzed as a basis for data-driven interventions and assessment policies, this Office, through the Curriculum and Learning Management Division (CLMD), shall conduct the Regional Training on NAT Analytics: Transforming Assessment Results into Insights on February 23-24, 2026, in Eastern Samar. The specific venue and other pertinent details will be communicated through a separate memorandum.
2. The NAT Analytics training aims to provide Technical Assistance (TA) on the implementation of the assessment mechanism through the following:
 - a. gathering insights from the DTCs on their experiences in implementing assessment initiatives in their respective divisions;
 - b. discussing the utilization of the **Jamovi** application for data analysis; and
 - c. developing a consolidated analytical report on the NAT results.
3. The participants in this training are the thirteen (13) Division Testing Coordinators (DTCs), as indicated in Enclosure No. 1 of this Memorandum.
4. If the Division Testing Coordinator (DTC) is unable to attend, the name of the authorized representative shall be submitted to the Regional Testing Coordinator at least one (1) week before the conduct of the activity to ensure proper documentation and issuance of the corresponding certificate of participation.
5. For the guidance of all concerned, the Training Matrix is attached to this Memorandum as Enclosure No. 2.
6. Training-related expenses shall be charged against the Program Support Fund (PSF) for the Training on NAT Analysis downloaded to the Schools Division of Eastern Samar. Travel and incidental expenses of the Program Management Team (PMT), Technical Working Group (TWG) members, and participants shall be charged against their respective local funds or the NASBE Second Tranche Fund, subject to the availability of funds and existing accounting and auditing rules and regulations.
