**WHEREAS**, the DepEd Regional Office No. VIII advertised the Invitation to Bid the **PROCUREMENT FOR LEASE OF VENUE WITH FOOD AND ACCOMMODATION FOR THE REGIONAL TRAINING OF TRAINERS ON THE STRENGTHENED SHS CURRICULUM LOT 1 & 2** posted in the PhilGEPS, DepEd RO8 Procurement Websites and in the BAC Bulletin Board in the DepEd Regional Office VIII for seven (7) calendar days;

**WHEREAS**, pursuant to Section 10, Rule IV of the IRR of R.A. 9184, a competitive bidding was conducted by the BAC for the above-mentioned project with the following Approved Budget for the Contract (ABC) indicated below;

**WHEREAS**, as to the date of the deadline of submission and the opening of bids on **May 13, 2026**, a lone bidder purchased for this procurement and submitted his proposal for Lots 1 & 2 on or before the deadline of submission and receipts of bids;

**WHEREAS**, under Section 35.1 (b) of R.A. 9184 and its IRR, the lone bidder was declared ineligible in view of expired Platinum PhilGeps Registration”;

**NOW, THEREFORE**, We, the Members of the Bids and Awards Committee, hereby **RESOLVE AS HEREBY RESOLVED**:

- 1) To declare a failure of bidding for the **PROCUREMENT FOR LEASE OF VENUE WITH FOOD AND ACCOMMODATION FOR THE REGIONAL TRAINING OF TRAINERS ON THE STRENGTHENED SHS CURRICULUM LOT 1 & 2** and recommend to the End-User for the downloading of funds to the SDOs in view that a re-bidding is no longer applicable as the opening of bids will already be after the opening of classes;
- 2) To recommend for approval to the Regional Director as the Head of the Procuring Entity (HoPE) the foregoing declaration.
