

Contract Agreement Form for the Procurement of Goods (Revised)
(Not required to be submitted with the Bid, but it shall be submitted within ten (10) days after receiving the Notice of Award)

CONTRACT AGREEMENT No. 09-76

THIS AGREEMENT made the ____ day of 18 MAY 2026 between **DEPARTMENT OF EDUCATION REGIONAL OFFICE VIII**, represented by **DR. SALUSTIANO T. JIMENEZ, CESO III**, in her capacity as the **REGIONAL DIRECTOR** of the **DEPED RO VIII**, hereinafter referred to as the "**Entity**"; and **RONVER ENTERPRISES** of **CATARMAN, NORTHERN SAMAR** hereinafter called "**the Supplier**" of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly **PROCUREMENT FOR UNIFORMS OF THE EVRAA DELEGATION TO THE 2026 PALARONG-PAMBANSA** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **Philippine Pesos One Million Nine Hundred Forty-Four Thousand Five Hundred Nineteen Pesos (Php 1,944,519.00) only**, hereinafter called "the Contract Price".

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, *viz*:

- i. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any
- ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (*e.g.*, Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

 - iv. Notice of Award of Contract and the Bidder's conforme thereto; and
 - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Order, and Warranty Security, shall likewise form part of the Contract.**
3. In consideration for the sum of **Philippine Pesos One Million Nine Hundred Forty-Four Thousand Five Hundred Nineteen Pesos (Php 1,944,519.00) only** or such other sums as may be ascertained, **RONVER ENTERPRISES** agrees to the **PROCUREMENT FOR UNIFORMS OF THE EVRAA DELEGATION TO THE 2026 PALARONG PAMBANSA** in accordance with his/her/its Bid.
4. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby enters into a covenant with the Entity to execute and complete the Works within a period of **TEN (10) CALENDAR DAYS** in conformity with the provisions of this Contract in all respects, and in accordance with governing laws, rules and regulations.
5. That the Supplier must adhere to follow the revised Specification and deliver the goods on or before May 22, 2026 in Sta. Irene ES/NHS, Prosperidad, Agusan Del Sur as per issued Bid Bulletin No. 1.
6. The Head of the Procuring Entity (HOPE) DR. SALUSTIANO T. JIMENEZ, CESO III, in his capacity as the REGIONAL DIRECTOR of the DEPED RO VIII agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.

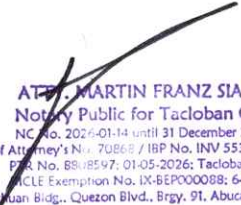
