CONTRACT AGREEMENT No. 10-26

THIS AGREEMENT made the JUN 22 2026 day of _____ between **DEPARTMENT OF EDUCATION REGIONAL OFFICE VIII**, represented by **DR. SALUSTIANO T. JIMENEZ, CESO III**, in her capacity as the **REGIONAL DIRECTOR** of the **DEPED RO VIII**, hereinafter referred to as the "**Entity**"; and **NIKKA TRADING** of **MAKATI CITY, PHILIPPINES** hereinafter called "**the Supplier**" of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly **PROCUREMENT AND DOOR TO DOOR DELIVERY FOR FY 2026 LEARNING TOOLS AND EQUIPMENT-SCIENCE AND MATHEMATICS EQUIPMENT TO THE RECIPIENT SCHOOLS** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **Philippine Pesos Ninety-Eight Million Seven Hundred Eighty-Seven Thousand Six Hundred Thirty-Five and 45/100 Pesos (Php 98,787,635.45) only**, hereinafter called "the Contract Price".

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, *viz:*
 - i. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any
 - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;




 - iv. Notice of Award of Contract and the Bidder's conforme thereto; and
 - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Order, and Warranty Security, shall likewise form part of the Contract.**
3. In consideration for the sum of **Philippine Pesos Ninety-Eight Million Seven Hundred Eighty-Seven Thousand Six Hundred Thirty-Five and 45/100 Pesos (Php 98,787,635.45)) only** or such other sums as may be ascertained, **NIKKA TRADING** agrees to the **PROCUREMENT AND DOOR TO DOOR DELIVERY FOR FY 2026 LEARNING TOOLS AND EQUIPMENT-SCIENCE AND MATHEMATICS EQUIPMENT TO THE RECEIPIENT SCHOOLS** in accordance with his/her/its Bid.
 4. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby enters into a covenant with the Entity to execute and complete the Works within a period of **ONE HUNDRED TWENTY (120) CALENDAR DAYS** in conformity with the provisions of this Contract in all respects, and in accordance with governing laws, rules and regulations.
 5. That the Supplier must adhere to follow the revised Specification and deliver the goods to the different recipient schools of the 13 Schools Division Offices within 120 calendar days after the issuance of Notice to Proceed (NTP).
 6. The Head of the Procuring Entity (HOPE) DR. SALUSTIANO T. JIMENEZ, CESO III, in his capacity as the REGIONAL DIRECTOR of the DEPED RO VIII agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
