“BAYANIHAN PARA SA BALIKBAYANG MANGGAGAWA”: A NATIONAL  
REINTEGRATION NETWORK (BBM-NRN) FAIR**

1. In reference to Memorandum **DM-OUHROD-2026-1024**, this Office announces the participation of SPIMS incumbent public school teachers in the **“Bayanihan Para sa Balikbayang Manggagawa”: A National Reintegration Network (BBM-NRN) Fair**, to be conducted on **April 13–16, 2026**, at the Leyte National High School Gym, Tacloban City.
2. The activity aims to support the reintegration of returning Overseas Filipino Workers (OFWs) through the Sa Pinas, Ikaw ang Ma’am at Sir (SPIMS) Program, particularly highlighting the Balik-Turo initiative, which enables qualified returning Filipinos to join the teaching workforce and contribute meaningfully to the basic education sector.
3. The Tacloban City Division shall serve as the host division for this activity, in coordination with the Regional Office and partner agencies involved in the National Reintegration Network.
4. Participants to this activity shall include the following:
  - a. Selected members of the Technical Working Group (TWG) from the Regional Office;
  - b. Selected members of the Technical Working Group (TWG) from the Tacloban City Division Office; and
  - c. Fifty (50) SPIMS incumbent public school teachers from the thirteen (13) Schools Division Offices of Region VIII. Below is the distribution of participants:
