This Office, through the Curriculum and Learning Management Division (CLMD), disseminates information on the conduct of the **Department of Labor and Employment (DOLE) National Job Fair** in celebration of the **2026 Labor Day**, with the theme **“Disenteng Trabaho Para sa Lahat: Iisang Hangarin, Bagong Pilipinas Sama-samang Mararating.”**

6. Immediate dissemination of and compliance with this Memorandum are desired.

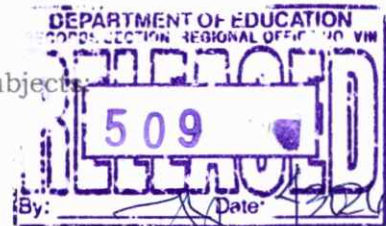
