Pursuant to Section 9 of the Republic Act No. 12080, otherwise known as the *Basic Education Mental Health and Well-Being Promotion Act*, which mandates the conversion, reclassification, or both of the positions of Guidance Counselor and Guidance Coordinator into the newly established positions, all existing mental health and well-being professional positions in the Schools Division Offices (SDO) shall be transitioned accordingly. This transition shall be effected through reclassification or retitling to the appropriate School Counselor and School Counselor Associate positions, in accordance with the proposed Qualification Standards (QS) and compensation scheme, as determined by the Department of Education (DepEd), Department of Budget and Management (DBM), and Civil Service Commission (CSC).

As stipulated in DM-OUHROD-2026-0135, the Bureau of Human Resource and Organizational Development (BHROD) shall facilitate the following:

1. Conversion of existing vacant, dormant Guidance Counselor and Guidance Coordinator positions to School Counselor Associate I (SCA I) (SG-11) positions through scrap-and-build process.

**2. Reclassification (or retitling<sup>1</sup>) of existing filled positions to appropriate new position titles, subject to the qualification of the incumbent vis-à-vis the Qualification Standards (QS) as approved by the CSC.**

In connection with the submission of the indicative list of positions proposed for reclassification and/or retitling, and guided by DepEd Advisory titled *Deadline Extension for The Submission of the Position Allocation List (PAL)* released on 20 February 2026, as well as DM-OUHROD-2026-0542 titled *Amendment to the Performance Requirement and FAQs on the Reclassification of Guidance Counselor and Guidance Coordinator Positions Pursuant to RA 12080*, all Regional Office (RO) and SDO Human Resource Management Officers (HRMO) were directed to undertake the following:

- a. Conduct an initial evaluation of **all** incumbents based on the proposed QS, and
- b. Submit the duly signed PAL to BHROD-Organization Effective Division (OED) for onward submission to DBM Central Office.

In view of the foregoing, the results of validation based on the submitted PAL of the ROs and cross-checked with the accomplished Plantilla Monitoring Tool, showing that there are **175 Guidance-related incumbents with no submission of application for reclassification or retitling**, are summarized below:

For clarification, please be guided by the following cases:

**1. Positions tagged Coterminous to the Incumbent (CTI)**

Guidance counseling-related plantilla items that are currently tagged as CTI in the Personnel Services Itemized Plantilla of Personnel (PSIPOP) are permitted and required to undergo the reclassification/retiling process, in accordance with Section 9 of RA 12080.

**2. Incumbents with Salary Grade 16 and Above Without the Required Eligibility**

Incumbents in guidance-related positions with Salary Grade 16 and above who do not meet the prescribed eligibility requirements shall have their positions:

- Retitled to the equivalent School Counselor position, and
- Tagged as Coterminous to the Incumbent (CTI).
