Pursuant to DepEd Memorandum OM-OUGOPS-2026-02-01383 titled "*Implementation of Khan Academy for School Year 2026-2027*," this Office, through the Curriculum and Learning Management Division (CLMD), hereby announces the designation of the Division Khan Academy Focal Persons (DKFPs) in the thirteen (13) Schools Division Offices (SDOs) of DepEd Region VIII.
