3. Immediate dissemination of and compliance with this Memorandum is desired.

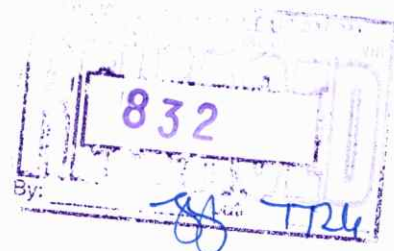
