The Department of Education, Regional Office No. VIII through the Quality Assurance Division (QAD) announces the **TEMPORARY CLOSURE** of **ARC ANGELUS CIVITAS SCHOOL, INC.**, Brgy. 84, Cogon Road, San Jose, Tacloban City, Division of Tacloban City with School ID No. 407353 and Government Recognition No. 04, s. 2024 for kindergarten, effective School Year 2026-2027. The voluntary temporary closure of the said school is pursuant to Section 43 of DepEd Order No. 88, s. 2010, as per communication received from the School Administrator and officially endorsed by the Schools Division Superintendent. The closure is requested on the grounds that the restoration of damaged school infrastructure was severely delayed due to a critical shortage of available local construction manpower, thereby rendering the institution unable to meet the scheduled opening of classes for SY 2026-2027.
2. The Schools Division Superintendent is hereby empowered to facilitate the safekeeping and repository/archive of all the pertinent documents following the guidelines stated in DepEd Order No. 88, s. 2010, Custody of Student Records.
3. Immediate dissemination of and strict compliance with this Memorandum are desired.

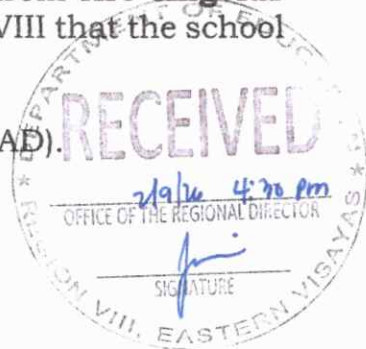

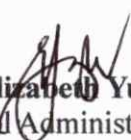
