**CONDUCT OF THE MID-YEAR REVIEW OF THE OFFICE PERFORMANCE

1. Pursuant to DepEd Order No. 2, s. 2015, entitled **Guidelines on the Establishment and Implementation of the Results-Based Performance Management System (RPMS)** in the Department of Education, this Office shall conduct the **Mid-Year Review of the Office Performance Commitment and Review Form (OPCRF) of Schools Division Offices (SDOs)** on July 27-28, 2026, during the Regional Management Committee Meeting. The review aims to ensure the alignment of performance commitments with the Department's strategic priorities and to assess the progress of the SDOs in the implementation of their Calendar Year (CY) 2026 targets.
2. The objectives of the activity are as follows;
 - a. Present the accomplishments of SDOs for the first half of Calendar Year 2026 (January- June, 2026);
 - b. Identify gaps, challenges, and best practices in the delivery of programs, projects, and activities; and
 - c. Provide feedback and guidance for the remaining implementation period of the year.
4. All SDOs are requested to conduct their respective Mid-Year OPCRf Review prior to their presentation during the Regional Management Committee Meeting.
3. Each SDO shall be allotted **15 minutes** for the presentation and reactors are given **5 minutes** for the comments and recommendations. 5. All functional Division Chiefs of the Regional Office shall serve as validators during the presentation.
