**CONDUCT OF ELECTION OF THE NATIONAL EMPLOYEES' UNION-
REGIONAL OFFICE VIII CHAPTER**

To: Regional Office Personnel
All Other Concerned

1. Section 9, Article V of the Constitution and By-Laws of the Department of Education-National Employees Union states that:

In case of vacancies, except in the Office of the National President, the same may be filled up by appointment or by special election. In case of the former, the president shall submit two (2) names of nominees to the NBOT which shall elect who may be appointed to fill the vacant position. Those appointed/elected to fill the vacancy shall serve only for the unexpired period of the term of the replaced officials.

2. Relative thereto, and in view of the retirement of Dr. Elemer Albert E. Cuevas, NEU-Regional Office President, a special election shall be conducted on August 10, 2026, immediately following the Flag Raising Ceremony.

3. The election shall cover the following positions, which will replace all incumbent officers who have served for the past three (3) years:

- a. President
- b. Vice-President
- c. Secretary
- d. Treasurer
- e. Auditor
- f. Public Relations Officer
- g. Two (2) Project Officers

4. The elected officers shall serve a term of three (3) years, effective upon their official oath of office. The highest elected officer holding a second-level position shall automatically represent the employees in various committees requiring representation, such as the Human Resource Merit Promotion and Selection Board (HRMPSB), Performance Management Team (PMT), Program on Awards and Incentives for Service Excellence (PRAISE), and other similar committees.

5. In the event that the highest elected officer is unavailable, representation shall automatically pass to the next officer in succession, following the established order of hierarchy.

6. Candidates for elective positions must be members of the Union in good standing for a minimum period of one (1) year as of the date of the election. Attached herewith is the list of members in good standing, specifically those who regularly remit the monthly dues of One Hundred Fifty Pesos (PhP150.00) through salary deduction.
