REGIONAL TRAINING ON THE 2027 PALARONG PAMBANSA SCREENING AND ACCREDITATION PROCESS

To: Schools Division Superintendents
All Others Concerned

1. In preparation of the upcoming conduct of the lower meets in all Schools Division Office (SDOs), the Regional Screening Accreditation Committee (RSAC) will conduct a conference to discuss the relevant provisions of DepEd Memorandum OM-OUOPS-05-2025-01337 and DepEd Memorandum OM-UGOPS-2026-05-08594, particularly on the eligibility and documentary requirements of athletes, coaches and chaperones; preparation of Palarong Pambansa forms, masterlists, and athletes' PasSports; Para Games guidelines; classification of athletic learners and other matters pertinent to the screening and accreditation of athletes, coaches, and chaperones.
2. This activity aims to:
 - a. capacitate the members of the Regional/Division Screening and Accreditation Committee on the revised rules on screening and accreditation of athletes and coaches for Palarong Pambansa and other relevant updates on the said rule that will be cascaded on the National Training on the 2027 Palarong Pambansa Screening and Accreditation Process that will be held on August 24-27, 2026 in Baguio City; and
 - b. enhance the system for the digitization of documents, preparation of PasSport and gallery and the finalization of masterlist.
3. The participants in this activity shall include the members of the Regional Screening and Accreditation Committee (RSAC) or their designated representatives from the Division Screening and Accreditation Committees (DSACs); one member of the Data Core Group of each SDO's DSAC; the Regional Sports Officer; one member from the EVRAA Technical Working Group (TWG), as indicated in Enclosure No. 1 and the members of the Division Screening and Accreditation Committee of SDO Calbayog City.
4. The conference shall be held on September 30 to October 1, 2026, at the Conference Hall of the Schools Division Office of Calbayog City. The program of activities is attached as Enclosure No. 2.
5. All expenses relative to the conduct of this activity including travel, meal and accommodation shall be taken from the participant's MOOE/local funds/School Education Fund (SEF) subject to the existing government accounting and auditing rules and procedures.

6. This Regional Memorandum shall serve as Travel Authority of the personnel indicated in Enclosure No. 1.
7. Immediate dissemination and compliance with this Memorandum are desired.
