1. Pursuant to Memorandum No. OM-OUGOPS-2026-11-2815 dated July 20, 2026, issued by the Office of the Undersecretary for Governance and Operations, the Education Support Services Division–Special Programs and Projects Section (ESSD-SPPS), DepEd Regional Office VIII, hereby identifies the Regional participants for the Orientation for the KAAGAPAY Program and Strengthening Collaboration Between Parents and Educators on Learner Rights and Protection for Cluster 1, to be held on August 18–21, 2026 in Iloilo City.
