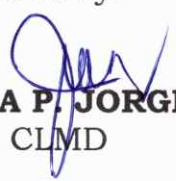

1. As part of this Region's commitment to continuous quality improvement and to ensuring operational efficiency in the delivery of key learner-centered programs, this Office, through the Curriculum and Learning Management Division (CLMD), shall conduct the **Post-Evaluation Conference on the 2026 NFOT-RFOT and NSPC-RSPC** on **August 12-13, 2026** at a venue to be announced through a subsequent advisory.
2. The activity aims to achieve the following objectives:
  - a. assess and review the implementation of the 2026 NFOT-RFOT and NSPC-RSPC by identifying best practices, major bottlenecks, and critical areas of concern across all working committees;
  - b. analyze the financial, logistical, and technical management of the host division and the regional management team;
  - c. evaluate the performances and feedback of the delegation participants (learners, coaches, and working committees); and
  - d. formulate strategic recommendations and initial action steps (Ways Forward) in preparation for the subsequent Regional and National level events.
