**STRONGER TOGETHER FOR LEARNERS: 4PS REGIONAL ADVISORY COUNCIL
MEETING CUM PARTNERSHIP CONVERGENCE**

To: Schools Division Superintendents
All Others Concerned

1. The Department of Education Regional Office VIII, in coordination with the Department of Social Welfare and Development (DSWD) shall conduct the **Stronger Together for Learners: 4Ps Regional Advisory Council Meeting cum Partnership Convergence** on **September 22, 2026**, to strengthen inter-agency collaboration and ensure coordinated support for learners and their families, particularly those covered by the Pantawid Pamilyang Pilipino Program (4Ps).
