1. This Office, through the Administrative Division, shall conduct a **Coordination Meeting with the Government Financial Institutions, Private Lending Institutions, Insurance Companies, Payroll Incharge, and Loan Verifiers** on **October 14, 2026, 9:00AM** onwards at the Training Hall 1, NEAP_R, DepEd Regional Office No. VIII, Government Center, Candahug, Palo, Leyte.
2. The objectives of the said meeting are the following:
 - a. update PLIs/GFIs on the revised loan terms of payment under the DepEd's Automatic Payroll Deduction System (APDS) Program;
 - b. reiterate salient provisions of DepEd Order No. 20, s. 2021 (Enhanced Guidelines on Accreditation/Re-Accreditation of Private Entities Under the Automatic Payroll Deduction System Program);
 - c. status of payroll operations at the Schools Division Offices; and
 - d. other issues and concerns.
3. The participants to this activity are:
 - a. representatives from the Government Financial Institutions, Private Lending Institutions/Insurance Companies
 - b. RO Chiefs and Supervising Administrative Officers of the Administrative and Finance Divisions
 - c. Regional Accountant, Regional Cashier, and Regional Payroll Services Head and Staff
 - d. One (1) Payroll Incharge and One (1) Loan Verifier per SDO
4. Travel and other incidental expenses of the participants from other institutions/agencies and Schools Division Offices shall be charged to their institution/agency/local funds while expenses for one (1) lunch, morning and afternoon snacks and venue rental to Regional Office funds subject to the usual accounting and auditing rules and regulations.
5. Immediate dissemination of and compliance with this Memorandum are desired.
