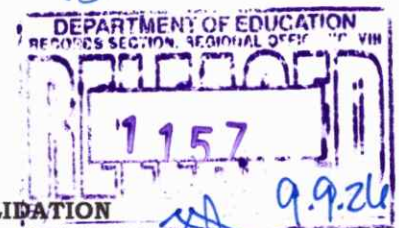

IN PRIVATE EDUCATION (E-GASTPE) PROGRAMS

1. This Office, through the Quality Assurance Division, informs the field of the Schedule for the Conduct of Validation of Beneficiaries of the Enhanced Government Assistance for Students and Teachers in Private Education (E-GASTPE) for SY 2026-2027. The validation activities shall be conducted simultaneously by two (2) teams from September to October 2026.
2. This activity aims to:
 - a. ensure that subsidies are granted only to eligible learners and teacher-beneficiaries of the E-GASTPE programs;
 - b. verify the eligibility of beneficiaries against the prescribed eligibility requirements; and
 - c. validate the existence and authenticity of the identified beneficiaries.
3. The composition of the Regional Validation Teams and the schedule for the validation of E-GASTPE-participating schools under each Schools Division Office (SDO) are attached as Enclosure No. 1.
4. Schools Division Offices (SDOs) are requested to designate at least four (4) representatives to join the Regional Validation Team in the conduct of eligibility verification and validation of E-GASTPE grantees.
5. Travel expenses incurred during the conduct of the said activities shall be charged against local funds, subject to the availability of funds and the usual accounting and auditing rules and regulations

6. Immediate dissemination of and strict compliance with this Memorandum are desired.
