When necessary, the members of the TWC may commence their close-in preparations on September 16, 2026, particularly for the sorting, organization, and packing of resources at Hotel de Fides, Tacloban City, as well as for the conduct of all necessary rehearsals and final preparations for the scheduled program performances.

3. All participants shall be at the venue not later than 5:00 a.m. on September 19, 2026 for the final rehearsal and necessary pre-program preparations. This early call time is imperative in view of the anticipated venue lockdown at 7:00 a.m. Accordingly, all participants shall be in their respective designated seats not later than 6:30 a.m. to facilitate final security, logistical, and program arrangements.

4. In this regard, participants who are required to travel from other Schools Division Offices (SDOs) are advised to arrive in Tacloban City on or before 5 AM of September 19, 2026, to ensure their readiness and availability for any final instructions, coordination, or other last-minute preparations prior to the event.

5. Provision of service credit/compensatory time-off must be consistent with the rulings under DepEd Order No. 13, s. 2024 and COA-DBM Joint Circular No. 1, s. 2015 and No. 1, s. 2022

6. The Post-Event Evaluation shall be conducted on September 20, 2026, at RELC-NEAP Training Hall 1, DepEd Regional Office VIII, Government Center, Candahug, Palo, Leyte. All Committee Chairs and Co-Chairs are enjoined to attend the evaluation to assess the overall implementation of the activity, document significant observations and recommendations, and identify appropriate measures for succeeding activities.

7. All other provisions, committee compositions, functions, assignments, and directives contained in RM Nos. 972 and 1087, s. 2026 shall remain in full force and effect, insofar as they are not inconsistent with this issuance.

8. All concerned are hereby enjoined to extend their full cooperation and support to the designated committee members and to ensure the successful, orderly, and meaningful observance of the 2026 National Teachers Month Celebration, consistent with the objectives and directives of the Department of Education.
